

  - (a) in the case of the Balance Sheet, of the state of affairs of the Company as at March 31, 2015 and
  - (b) in the case of the Statement of Profit and Loss, of the profit for the year ended on that date.

#### **Basis for Qualification**

As per the Revised Schedule VI, deferment of expenses is not allowed. Hence, by not doing this, the profit and assets of the company is overstated by the amount of Rs. 2,36,42,462/-. Further, the company has written off I/I0th of the total deferred expenses of last year.

#### **NOTES TO FINANCIAL STATEMENTS**



#### FOR THE YEAR ENDED 31ST MARCH 2015

#### I. Significant Accounting Policies

#### I.I Basis of preparation

The financial statements of the company have been prepared in accordance with generally accepted accounting principles in India (Indian GAAP). The company has prepared these financial statements to comply in all material respects with the accounting standards notified under the Companies (Accounting Standards) Rule, 2006, (as amended) and the relevant provisions of the Companies Act, 2013. The financial statements have been prepared on an accrual basis and under the historical cost convention.

The accounting policies adopted in the preparation of financial statements are consistent with those of previous year.

#### 1.2 Use of Estimates:

The preparation of financial statements in conformity with Indian GAAP requires the management to make judgments, estimates and assumptions that affect the reported amounts of revenue, expenses, assets and liabilities and the disclosure of contingent liabilities, at the end of the reporting period. Although these estimates are based on the management's best knowledge of current events and actions, uncertainty about these assumptions and estimates could result in the outcomes requiring a material adjustment to the carrying amounts of assets or liabilities in future periods.

#### 1.3 Revenue Recognition

Revenue is recognized to the extent that it is probable that the economic benefits will flow to the company and the revenue can be reliably measured. The following specific recognition criteria must also be met before revenue is recongized:

#### a) Income from Services:

Revenues from services are recognized as and when services are rendered. The company collects Service tax on behalf of the government and, therefore, it is not an economic benefit flowing to the company. Hence, it is excluded from revenue.

#### b) Interest Income:

Interest Income from bank deposits and investments is recognised on accrual basis.

#### c) Other Income:

Income and expenditure are generally recognised on accrual basis except (a) Silver recovered from dross, (b) Member's subscription, (c) Bulletin subscription Income are accounted for on cash basis.

#### d) Dividend Income:

Dividend Income is recognised in the year in which the right to receive dividend is known.

#### 1.4 Inventories

Stores and spares and consumables are valued at lower of cost or net realizable value. However materials and other items held for use in the production of inventories are not written down below cost if the finished products in which they will be incorporated are expected to be sold at or above cost. Cost of stores and spares and other consumables are determined on a weighted average basis.

Net realizable value is the estimated selling price in the ordinary course of business, less estimated costs of completion and estimated costs necessary to make the sale.

#### 1.5 Tangible Fixed Assets

Fixed assets are stated at cost of acquisition less accumulated depreciation. Cost comprises the purchase price and any attributable cost for bringing the assets to working condition for its intended use.

#### 1.6 Depreciation on Tangible Fixed Assets

Depreciation on fixed assets is calculated on a written down value using the lifes arrived at based on the useful lives prescribed under the Schedule II to the Companies Act, 2013.

#### 1.7 Impairment of Tangible and Intangible Assets:

The company identifies impairable assets at the year-end in terms of para-5 to 13 of Accounting Standard 28 - Impairment of Assets for the purpose of arriving at impairment loss thereon being the difference between the book value and recoverable value and impairment loss is recognised.

#### 1.8 Investments:

Investments, which are readily realizable and intended to the held for not more than one year from the date on which such investments are made, are classified as current investments. All other investments are classified as long term investments.

Current investments are carried in the financial statements at lower of cost and fair value determined on an individual investment basis. Long Term Investments are carried at cost. However, provision for diminution in value is made to recognize a decline other than temporary in the value of the investments.

In accordance with the Revised Schedule III to the Companies Act, 2013, the portion of the Long Term Investments classified above, and expected to be realised within 12 months of the reporting date, have been classified as current investments.

On disposal of an investment, the difference between its carrying amount and net disposal proceeds is charged or credited to the statement of profit and loss.

#### 1.9 Retirement and other employee benefits

Contributions to the Provident Fund are made at a pre-determined rate and charged to the Statement of Profit and Loss. Provision for gratuity is made on actuarial valuation basis as per Accounting Standard 15 - Employee Benefits. Provision for Leave encashment is made on accrual basis on estimates as at the year-end and is charged to Statement of Profit and Loss.

#### 1.10 Leases

Where the Company is lessor

Leases, where the lessor effectively retains substantially all the risks and benefits of ownership of the leased item, are classified as operating leases. Operating lease payments are recognized as an expense in the Statement of Profit & Loss on a straight-line basis over the lease term as per Accounting Standard 19 - Leases

#### **I.II Income Taxes**

Provision for current tax and fringe benefit tax is made after taking into consideration benefits admissible under the provisions of the Income-tax Act, 1961.

Deferred tax resulting from "timing difference" between book and taxable profit is accounted for using the tax rates and laws that have been enacted or substantively enacted as on the balance sheet date. The deferred tax asset is recognised and carried forward only to the extent that there is a reasonable certainty that the asset will be realised in future.

#### 1.12 Provisions

A provisions is recognized when the company has a present obligation as a result of past event, it is probable that an outflow of resources embodying economic benefits will be required to settle the obligation and a reliable estimate can be made of the amount of the obligation. Provisions are not discounted to their present value and are determined based on the best estimate required to settle the obligation at the reporting date. These estimates are reviewed at each reporting date and adjusted to reflect the current best estimates.

Where the company expects some or all of a provision to be reimbursed, for example under an insurance contract, the reimbursement is recognized as a separate asset but only when the reimbursement is virtually ertian. The expense relating to any provision is presented in the statement of profit and loss net of any reimbursement.

#### 1.13 Contingent Liabilities
